APPLICATION RATES: Dissolved formula will treat the following volumes of seed per unit: **Alfalfa:** 1250 lbs.

Canola: 1250 lbs. **Corn:** 50 units.

Cotton: 30 units*. **Grain Sorghum:** 25 units. **Sunflowers:** 37-40 units.

MIXING INSTRUCTIONS:

Mix small Liquid cylinder (Part B) into gallon jug (Part A) then pour dry (part C) into liquid jug (Part A) hold cylinder down into liquid jug to avoid dust. Pour all the dry ingredients into liquid solution, wear gloves and shake well.

***Invigor 8™ should not be used on cotton seed already treated with Di-syston®.**
